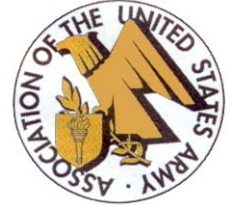

After many months without a Chapter Secretary, the job was filled by **Command Sergeant Major Alan Callanan**, who retired from the Nevada Army National Guard in December of 2007.

Alan was born and educated in Detroit, Michigan, graduating from high school in 1965. His military career started with a draft notice which he quickly converted to an enlistment and active duty as a Finance Specialist until 1980. During those years he earned a Bachelor of Arts Degree from the Detroit Institute of Technology adding a Masters Degree from the University of Phoenix in 2002. Three years earlier he graduated from the Sergeants Major Academy.

His overseas assignments include four tours in Korea, assignments in Panama, Germany and a year in Afghanistan with the Headquarters of the 209th Corps. He has also served with Army Reserve units in four states before joining the Nevada Army National Guard in 1993. His last assignment before retirement was as the Command Sergeant Major of the 422nd Signal Battalion. His decorations include the Legion of Merit, the Bronze Star Medal, the Meritorious Achievement Medal, five awards of the Army Commendation Medal and one award of the Air Force Commendation Medal.

Alan and his wife, Shane, live in Carson City, as well as do two adult daughters. He is currently working as a recruiter for the Battle Born Challenge program for at risk youths.

SALUTE TO SALLY

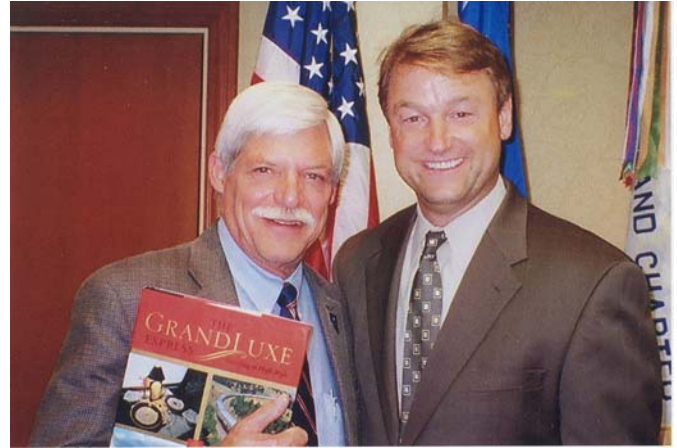
